Patti Brady-Glassman is retiring after celebrating her 30<sup>th</sup> year serving at OSU. She started working in the Office of Financial Aid at OSU as a graduate student employee in 1987 and went on to complete her master's degree at Oregon State. Her exceptional efforts were recognized, and she advanced to the position of Associate Director in 2002.

Over her career, Patti has earned a reputation for going above and beyond to assist students. She was involved in the development of the Degree Partnership Program that allows students to be simultaneously enrolled at OSU and a partner community college in Oregon and receive financial aid for their credits at both institutions. Patti has worked with various departments at OSU to facilitate the creation of hundreds of scholarships that have assisted thousands of students and is well-known as a scholarship expert.

She has been a leader at OSU and within the broader financial aid community. Patti has dedicated countless hours working with numerous committees for OASFAA through the years. She undertook the great responsibility and honor of being the OASFAA president in 2010-2011.

Patti has announced that she will be retiring at the conclusion of December 2018. After being such an influential and positive member of the financial aid community, we are sad to see her go, but want to wish Patti well on her next adventures!

Over the years, Patti and I returned annually to the Daly Fund meeting along with Michelle Holdway from UO. We grew to really appreciate the hospitality of the local people and the dedication of the fund to help students pay for school. The Daly Fund experience is certainly unique and we enjoyed some great steaks and wine over the years with both our families.

Beyond the Daly Fund, I'll certainly miss working with Patti within OASFAA and the times when I've consulted with her about how she would handle a situation. I wish her the very best in retirement and hope we still see her around."—Ryan West, Chemeketa Community College

#### **Legislative Updates**

#### Peter Goss, Portland Community College

Seasons greetings from the OASFAA legislative committee! After a period of relative quiescence, a lot is happening now or dancing on the horizon.

At the federal level, we've seen fixes to the law governing sharing of data with third party agencies, ED fail to deliver new regulations on a number of issues impacting Title IV including Gainful Employment and Borrower Defense, but issue new proposed regulations for Title IX.

The mid-term elections do mean a split House/Senate but the word from a number of folks who read the tea leaves in D.C. is that, as this is Sen. Alexander's last hurrah as chair of the 'HELP' committee which oversees education, he is going to be motivated to push ahead on reauthorization, and the election results may actually open the door to compromise on some areas where the two parties broadly agree at least on some basic principles such as: school accountability, FAFSA simplification, student debt, and workforce development.

The VA is undergoing a shakeup in leadership. Aside from having a new Secretary, in November the VA reassigned long-time head of their Education Services department in response to significant delays and cost overruns in implementing software changes required by the "Harry Colmery Forever GI Bill," which has led to significant impacts on timely delivery of tuition and housing benefits to hundreds of thousands of students this fall, and potentially into winter term.

At the state level, OSAC launched a new program this fall benefiting some national guard members attending public institutions, and rumors abound of other programs under consideration. The state legislature is gearing up for a full session in 2019, including Oregon's unusual biennial budgeting process. Advocacy is picking up, with lobbying supporting expanded funding for OOG, direct support for community colleges and universities, new programs, etc. It is nice that enthusiasm exists, though realistically the number of asks almost certainly exceeds capacity.

HECC put forward a 'legislative concept' package covering 11 items, including a 'Native American College Access Grant' and a proposed state income tax credit for student loan payments, among others, though it would be up to the legislature to turn those into actual bills. Gov. Brown's budget proposal is not available as of this writing, but will be out by the time you are reading this. As actual bills and budget numbers start coalescing, Susan and I will do our best to keep you abreast of the ones that most impact our offices.

And a sincere wish from us to you all for happy holidays, and a smooth, stress-free start of the next term!
